1. Created in the Image of God

- Family BBQ worried about losing funding if we are unable to do this in person this year, so not sure if this is the best option

8.0 REPORTS

8.1 Admin Report

- Went over results from parent survey our data represents results from only 10 parents.
- Jordan discussed the fact that "don't know" response = negative feedback. General discussion that parents need to understand this fact, that the survey is import, and that this could lead to real change in their schools (i.e. admin gets the feedback and makes changes)
- Jordan will follow up with Sacred Heart, as they tend to get a better response rate can not include incentives for completion
- General discussion about why social media comments are closed could we post social media questions for parental involvement?
- Specific strategies to work on: staff sharing faith with parents should be more visible
- Things we do well: we are a safe, caring, welcoming school

8.2 Trustee Report

Below are a few board highlights:

Due to the spike in Covid cases, one of the classes in our STAR schools have moved to on line learning. Three classes in other STAR schools are on "MONITOR" status. Five out of 12 schools have received their mask/rapid tests.

The board approved the allocation of 1.4 million dollars of unrestricted surplus to offset an anticipated shortfall in the 2022 budget due to lower enrollment because of the covid-19 pandemic. This decision is subject to approval by the Minister of Education The Division will continue to seek out opportunities to advocate that school authorities be held harmless by the Government of Alberta for enrollment-based funding for another school year.

We have scheduled another meeting with the City of Beaumont Mayor and councilors to discuss the high school land issue.
